Proposal

Plymouth CAST Multi Academy Trust is proposing to extend the age range of Our Lady & St Patrick's Roman Catholic Primary School, Teignmouth from 3-11 to 2-11 years of age.

The proposed implementation date, if the proposal is approved, is estimated to be from 1 September 2025.

Background

Our Lady & St Patrick's Roman Catholic Primary School, Teignmouth runs a nursery class offering early years provision for children from the age of 3 years old. The unit provides morning and afternoon sessions, with the option of children attending both and staying for lunch. Our



Lady & St Patrick's is seeking to open the nursery class up to 2 year-olds and thereby extend the age range of the school from 3-11 to 2-11 years of age. Plymouth CAST Multi Academy Trust has experience of operating 2 year old provision within Foundation Stage Units and Nursery Classes within the school structure and there is plenty of support available to the school. If approved, the school's Nursery Class would continue to operate from the main school building and the number of places offered could increase by up to five places. As with our existing arrangements, parents would still need to make a separate application to Devon County Council for a place in the Reception Class.

Benefits of the proposal

The school will be able to establish the strongest links possible with families from the outset working to support them from a younger age.

The leadership and management of a school must be strong, efficient and effective to enable high quality services to be delivered. The extended age Foundation Stage Unit will be an extension of the school services that will benefit children, families and the school community.

Children whose parents meet the free school meal eligibility criteria and attend for the whole day will be entitled to a free school meal. Parents will also be able to purchase a school meal for two year-old pupils.

A 2-year-old can get funded childcare if the parent/carer lives in England and is entitled to qualifying benefits.



Parents who wish to pay for childcare will be able to do this via Tax Free Childcare or via ParentPay directly to the school.

Staff

If the proposal is approved, the nursery class will continue to be run by qualified early years staff who are employed directly by the Academy Trust. A school is required to work to the statutory Early Years Foundation Stage framework that governs the ratios and qualifications of staffing.

Process and Decision-making

The consultation period will run from 5th March 2025 to 28th March 2025. All responses to this consultation will be carefully considered by the School, Plymouth CAST Multi Academy Trust & The Diocese of Plymouth before any decision is made by the Academy Trust to submit an application to the Department for Education (DfE) to change the age range of the school from 3-11 to 2-11.

If a decision is made to proceed with the proposal, following consideration of the consultation responses, an application will be made to the Department for Education (DfE) South West Regions Group. It is the DfE's South West's Region Group who will make the final decision on the proposal to extend the age range of Our Lady & St Patrick's Roman Catholic Primary School, Teignmouth from 3-11 to 2-11. The DfE will make this decision after considering responses received to the consultation and the application submitted by the Academy Trust. Please note that consultation responses will also therefore be shared with the DfE South West Regions Group.



Capital and planning

This proposal will not affect the Published Admission Number (PAN) for the school, nor the capacity for school aged children. Some capital remodelling will be required to accommodate the requirements of taking 2 year-olds within the school.
