#### 1. Message from Kate Griffin

Thank you for your contributions to the budget setting meetings last week. I am well aware of the financial difficulties that all schools are facing at present, but I hope that by working together we shall convince the EFA who are conducting a review of CAST finances that we are providing good value for money. I know that when you joined CAST you did so on the understanding that as much responsibility as possible would be delegated to schools; that was exactly the same in DoWAT (Diocese of Westminster Academy Trust) in 2012 when they were established, but by 2013 when I became a director it was clear that some things had to change for the good of all. I freely admit that there were some bumpy meetings of the board which by then I chaired; but the pain has been worth it. We were in Sir Michael Wilshaw's list of seven successful multi-academy trusts having achieved excellent results all round. I am sure that CAST can become equally successful as it is very clear that there is a huge amount of talent in our schools, but that can only happen by working more collaboratively.

#### 2. School Support

You will remember that I asked in my letter dated 3<sup>rd</sup> March 2017 that anyone interested in offering support to other schools should contact me. I am grateful to those who did and to those who are already helping schools in difficulty. I believe that CAST should and can become an organisation which supports and develops the talents of all within its reach. To provide further support from within CAST the Board has agreed that a Head of School Improvement should be appointed. The advertisement will go live on May 12<sup>th</sup> so please do have a look if you are interested in this opportunity.

## 3. Safeguarding Update

I would also like to update you on Safeguarding. At our last Board meeting it was agreed that Maria Edwards would continue to be the Board's Safeguarding representative but that this would be a non - executive position. Neil Maslen under the guidance of the interim CEO will take on the executive responsibility for producing a CAST wide safeguarding strategy which will include monitoring and reporting elements to ensure the Board is kept fully informed in order to fulfil its statutory duty. You will hear more from Neil in due course. The Board were very appreciative of the tremendous amount of work that Maria has done in this area and that she will continue to ensure that this is a priority at Board level.

## 4. **Regional Budget Seminars**

Regional budget seminars took place across the Trust on 25, 26 and 27 April to start the process of setting school budgets for the 2017/18 academic year.

These will be reviewed by the Finance committee and then the CAST Board before being submitted to the Educational and Skills Funding agency in July. A new requirement is upon us this year to submit a forecast of 'out turn' or in other words our forecast balances for this year on 19 May. Many thanks to all involved for their hard work and commitment.



## 5. CAST Functional Reviews

In October 2016 the Regional School Commissioner directed the Trust to conduct a series of reviews which are almost complete. These included Safeguarding, Pupil Premium, Leadership and Governance and, Financial Management. The first three are now complete and the Review into Financial Management is now underway to complete by 15 June 17. Bishop Fleming LLP will conduct the review and we have selected the ten schools below for a skills audit and consultation focusing on financial management. This will mostly involve the schools Senior Management Team and Governors by means of an online questionnaire. Contact will be made directly by Bishop Fleming who must conduct the review independently. Your help and support is much appreciated. We have made the auditors aware of SATS week and also half term dates. Any issues, questions or concerns to marcus.taylor@plymouthcast.org.uk It is important to note this is not a look into individual schools, it is designed to provide all round assurance of the Trust's overall financial management which cannot be established without consulting with our schools.

## 10. Mental Health First Aid (MHFA)

From Easter 2017 MHFA England will be offering secondary school staff the opportunity to attend a one day, Youth MHFA Schools course, at no cost! The Youth MHFA in Schools programme will be fully funded by the Department of Health with a value of £200 per person. This is the first year of the programme and the aim is to train at least one member of staff in over 1000 secondary schools, to become a Youth MHFA Champion.

Schools can apply to host one of the first 100 training courses and in return they will be offered up to four additional places per course. Schools should register their interest by emailing <u>schools@mhfaengland.org</u>, stating where in England you are located.

The training is well-received by teachers who have found it a very effective approach to supporting young people in their schools. In addition to the training courses, the MHFA website has a range of resources that you can download.
